VE Corner**By Bob Kratsch, FSO VE**

Remember that when doing inspections be sure the boat owner is aware that "recreational boats 16 feet and over used on coastal waters or the Great Lakes are required to carry a minimum of either: 1) three day and three night pyrotechnic devices 2) one day non-pyrotechnical device (flag) and one night non-pyrotechnic device (auto SOS light) or 3) a combination of 1) and 2). Recreational boats less than 16 feet on coastal waters or the Great Lakes need only carry night visual distress signals when operating from sunset to sunrise."

Any VE needing supplies (stickers or 7012 Vessel Safety Check forms) should contact me at 609-698-3868. Please remember June 27, 2009 is the date for the Pebble Beach Home Owners Association boat inspection and we will need a minimum of 6 people. Coffee & donuts will be provided at 8:30 AM and lunch at noon. The inspection time will be 9AM to 2 PM.

Obtaining a Boating Safety Certificate**By Barbara Bomengen, PE-FSO**

All persons who wish to operate a power vessel must possess a valid boating safety certificate by June 1, 2009 or face up to a \$500 fine. You can obtain this certificate by successfully completing an "About Boating Safety" (ABS) course or a "Boating Skills & Seamanship" course, which are provided by Flotilla 74. Last year 290 students successfully completed the About Boating Safely course and 20 successfully completed the Boating Skills & Seamanship course. This year 53 students completed the April ABS class; 50 are scheduled for the May class and 15 are scheduled for the June class. Fourteen Instructors certified by the NJ State Police teach these courses. They had to complete an on-line course, teach a 2 hour class and be fingerprinted to earn their credentials to be certified. The boating safety certificate can also be obtained without taking a course by taking a test and self certifying that you have had at least 100 hours of experience in operating a power vessel. You have only one chance to pass this test. If you do not pass, you will be required to take a classroom course. This option expires as of June 1, 2009. To take this test you will need: Identification including proof of age is required,

such as: motor vehicle drivers license, military i.d., county i.d., college i.d., passport. The fee is \$25.00, payable to the sponsoring Auxiliary unit. Suggested study materials include generic boating safety material supplemented by the New Jersey State Police Boating Safety Manual. The NJSP Boating Safety Manual is available at www.njsp.org For more information see the website shown in paragraph 1.

There will be a Flotilla 74 table in Dicks Sporting Goods store in Stafford Park 16/17 May to promote Boating Safety. The "Test-Out" test will be available there between 10 AM and 3PM Sat 16 May and Sun 17 May.
