Don't Forget Us...

Our Director, LCDR Herman G. Pinter will be leaving his position as Director of this District as he retires from the Coast Guard. Let's pause for a retrospective glance at the past two years and consider the direction in which Diraux, H. G. Pinter has guided us.

In the Spring 1972 issue of Topside the Director defined his goals and objectives. They were to phase in and make operative a system of parallel staffing, enlarge the weekly mailing system, make more projectors available for PEC's and revise the Diraux Memo system. These specific goals were to be worked into a general framework of reducing frivilous paperwork, continued growth of all Auxiliary programs and maintain the high standards expected in all business and social functions.

Since that writing, some twenty (20) months ago, I have seen positive action taken towards the fulfillment of each of these goals. Parallel staffing has been in effect for more than a year and a half. Frankly, it still has some rough edges, but overall the system is working well. My staff, in a majority of cases, is receiving the necessary data to make an accurate report more efficient than was previously possible.

Rumor has it that it took some fancy finagling to get purchase requests thru, but the Gloucester office now has the capacity to mail directly to the VFC's and SO-MAT's.

This, of course, is in addition to the weekly mail already going to Commodores, DSO's, DCP's and FC's. This, I feel, was a major contribution to insuring continuity as VFC's move up the Auxiliary chain.

Obtaining projectors was a project that required a critical eye to be kept on this District's operating budget, to insure that monies become available to purchase this much needed projection equipment. In fact we now have over 80 pieces of projection gear in the Southern Area as compared to less than 10 two years ago.

The starch was removed from the Diraux Memo System; fewer formal memorandums and more informal reminders, i.e., the weekly NOTES OF GENERAL INTEREST. Granted, his pictures were not "X" rated, but the information was markedly easier to assimilate, thus being of significant advantage to those enslaved in paperwork.

We have experienced with this counciling, growth in all areas and of course, all our rendezvous, meetings, dinners and the like have been as successful as ever. We all know how he could enjoy our rendezvous.

Although not one of his defined objectives, a major stride was taken when this District began using Auxiliary automated data rosters. The information provided on these roster printouts is a great aid to Flotillas and the Divisions. This indeed was an unforseen bonus from which we will continually derive benefit.

Considering that a director must work either with the concurrence or objection of 3100 Southern Area Auxiliarists, his position is quite tenuous. It is rare to find an individual who can set his goals, establish a plausible program and remain stalwart to insure that it achieves fruition.

It has been our pleasure to work with him, an asset to be associated with him and a genuine loss to say Good-Bye. We all wish you and your family good fortune!

REPORTS

In these times of relaxed morality, we often see words in newspapers and magazines that would have been taboo just a few short years ago. Since so-called "dirty" words are in common usage, there is no reason to eliminate them from TOPSIDE. In view of this I would like to discuss what many Auxiliarists consider the "dirtiest" word in the Auxiliary. What is that word? — REPORTS.

As an Auxiliarist progresses from BQ'd member to Examiner, Instructor, appointed and elected officer, reports become more and more important. It was during my terms as DSO-CE that I came to fully realize the true value and significance of each report. Without them, every Auxiliary Program would cease to exist, as would, eventually, the Auxiliary. Remember the story, "For want of a nail a shoe was lost, etc., etc., etc.,"

While I must admit that there is an abundance of reports to file, I must also state that each one is of utmost importance. I believe that there is no doubt that the BQ'd member is the very lifeblood that sustain our organization.

Congressional appropriations for the Auxiliary are based in direct proportion to our achievements. The only way that Congress can determine what we have accomplished is by the submission of ALL reports.

One report not submitted may seem most insignificant to an individual but when viewed from the National level it is just the opposite. Let us take for example, the CME Program. The failure by one examiner to submit just one examination means little, but suppose that every qualified active examiner in 1972 failed to submit one examination and we see that over 11,000 would not have been reported. This is a very considerable figure and would result in the reduction of funds appropriated. This holds true for each Auxiliary Program.

Flotilla 49 Takes Top Honors In Training Aids Contest Held At Our North East Rendezvous



After two weeks at the (N.B.S.S.) National Boating Safety School which has been in existence for almost a year located in Yorktown, Va., one wonders why this hadn't started long before now. The staff is headed by LCDR William H. Wilson, Jr. and manned by regular Coast Guardsmen. All the finest and most knowledgeable gentlemen gathered in one spot to dispense one theme, safe boating, your writer has ever witnessed. The two week course is divided in two parts; first week CME and all its latest rules, regulations, and teaching devices. The second week Instructor training and how to encourage Auxiliarists to do more instructing effectively. We had the most modern techniques including closed circuit TV with two monitors. After reviewing yourself on TV the staff and LCDR Wilson reviewed what you had done categorically. At the end of both weeks we received certificates acknowledging the successful completion of both courses. CAPT L. D. High, Commanding Officer of the Yorktown Coast Guard Base, took time out from his extremely busy schedule to welcome us to the base both weeks we were there. LCDR Clifford Banner flew down from Washington the last day of the first week to talk with us about our local Auxiliary problems and how Washington could help to straighten them out. There are only two problems with the courses taken nationally and both are relative. The first is time, the second is money. Both of these are important, but certainly not more important than the saving of lives by more safe boating in your local area.

The problem of geographic location arose: where should these courses be held? The answer was unanimous to keep the school at the Yorktown Coast Guard Base. This was because the base is set up to handle a school. its proximity to water, plus the historical

location and being on a National Military base. These courses should always be given with the idea of Auxiliarists gathering from all parts of the country to meet and to exchange ideas and problems and to meet the national military personnel that guide the Auxiliary. The by-product of these courses are many, varied, and unique and with the inaugural of the Auxiliarists participating there is no end to the good that can come from this type of education. This year, after seven months of activity, 7-12 has recorded 1,044 CME's compared with 752 at the same time last year; 364 support missions at Barnegat Light and Beach Haven Coast Guard Stations, compared with approximately the same number as last year; 24 assists as compared with 11: 21 SAR missions as compared to 15; 8 safety patrols, same as last year; 2 Regatta patrols against none last year.

In addition 7-12 has completed one 12lesson BS&S course, one 7-lesson Sailing Course, one 3-lesson course, three 1-lesson courses which include two for "Project 1,000,000", which taught safe boating to approximately 150 Boy Scouts. This places 7-12 ahead of last year on Public Education courses.

There have been 10 Specialty Course Certificates issued to Flotilla members and three new members have BQ'd this year, with definite plans for more qualified new members and specialty course examinations.

It appears Flotilla 7-12 may make the Director's Honor Roll for three years in a row, and carry away more hardware from the next Winter Conference.
