Hello from the Central Area! I am honored to be elected to a second term as one of your District representatives in the 5th Northern Region. Although 2021 has been a challenging year following the pandemic, we are starting to see some light at the end of a long tunnel. Now that I have completed my first year as D-Capt., let me tell you about the four Divisions in the Central area that I have had the pleasure of working with.

Division 1 serves the Northern area in Delaware between three flotillas. Among these members are seven Coxswains, eleven Boat Crew, nine Vessel Examiners, two RBS Visitors, five Instructors, one Air Crew, one Aid to Navigation Verifier and one Aux PA Specialist (AUXPA1). They have a total of 63 members. With dwindling and maturing membership two of the three flotillas have sixteen members or less. The other flotilla has thirty-four with only a few active members that hold several positions. We are advancing.

Division 4 serves the Southeastern Pennsylvania area from the Schuylkill River to the PA/DE state line with seven Flotillas. Division 4 has a total of 202 members which comprise of seven Coxswain, thirteen crew, twenty eight Vessel Examiners, eighteen Program Visitors, twenty Instructors and two Aid to Navigation Verifiers.

### Auxiliarist Explores the Jet in the Woods

Nothing quite captures the imagination than discovering the ruins of a lost military jet fighter. Recently COMO Joe Giannattasio discovered just such an aircraft hidden away in the wilds of Passaic County, NJ, seemingly just left behind and forgotten in the hilly northernmost part of the state.

When he was attending university in northern New Jersey, Giannattasio took introductory flight instruction at a nearby airport and recalled local pilots telling stories of a military jet that crashed in the heavy forest area of the region long ago.

Now a co-pilot in the Coast Guard Auxiliary Fifth Northern's Air Program and an avid aviation enthusiast, Giannattasio set out with a fellow adventurer in October to find the lost jet fighter. Far from the closest town and a long hike from the nearest road they bushwhacked through thick foliage and swampy mud until they found the skeletal remains of a Marine Lockheed T2V-1 Seastar where it still exists today, nestled in a remote and marshy patch of the West Milford forest.

The aircraft was a carrier-capable jet trainer for the United States Navy that entered service in 1957 and powered by a single jet engine. According to newspaper articles from the period, in 1967 while flying a training mission out of Brooklyn's Floyd Bennett Field the jet had a flame out and plunged. Amazingly, despite the ejection system failing, both pilots survived the crash and were found standing near the wreckage by the first responders on scene.

Somehow the plane remained largely intact from the crash and the military later airlifted the engine out for salvage but left the rest of the plane behind. There is now less of the plane remaining; yet it endures as a captivating mystery, silently falling apart and forgotten.

### Coast Guard Merchant Mariner Credentialing Policy Changes

Any crew member working on a commercial ship or yacht, needs STCW or "Standards of Training, Certification and Watchkeeping." STCW was conceived in 1978 and has been in force since April 1984. The IMO or International Maritime Organization worldwide, and the U.S. Coast Guard, nationally, oversee the STCW.

In 2010, the so-called "Manila Amendments" were adopted due to increased security awareness and development of new technologies.

Change 1 to Coast Guard Merchant Mariner Credentialling (CG-MMC) Letter 02-18, establishes guidelines for qualification of personnel seeking STCW. Endorsements for Basic and Advanced Polar Code Operations and Change 1 to CG-MMC Policy Letter 01-21 are included in the revised Guidelines for Qualifying for the SCTW.

Any crew member working on a commercial ship or yacht, needs the STCW so this affects a large number of individuals worldwide. Another aspect of the changes is the publication by the Coast Guard of Basic and Advanced IGF or Low-Flashpoint Fuels Code Operations.

A discussion of the requirements for renewal of the Basic and Advanced Polar Code Operations endorsements along with removal of transitional provisions that expired on 01 JUL 2020 are at the heart of the Coast Guard Change 1.

A method to renew endorsement of qualified instructors of the Basic or Advanced IGF (Low Flashpoint Fuels Code) Operations course was introduced by Change 1 to CG-MMC Policy Letter. Additionally, the change reduces the seagoing service requirements for renewal of the STCW for Basic and Advanced IGF Code Operations.

### **AUXDATA II Needs YOU!**

AUXDATA II the "Auxiliary's Information System of Record," depends on you to record your missions/ activities in a timely manner. Without your input, it cannot provide the statistics that are required to provide funding, from the Coast Guard, for Auxiliary activities and cannot provide the proper statistics required for reporting Auxiliary activities. Your skills, and occupation are also a very important part of your personal information in your member record. Today, more than ever, the Coast Guard depends on Auxiliary members to augment its services in many diverse areas. Currently, the focus on diversity is not about gender, ethnicity, religion, etc., but on personal skills. In 5NR, many members provide important assistance to the Coast Guard in many different areas and if your skills are recorded in your member record, that will assist the Coast Guard in contacting you for help when needed.

It is also important for you to record your missions with the correct Mission Code that corresponds with your Summary of Activities. The combination of the two is then verified by your Information Services Officer. Although all "99" mission codes are "lumped" together for budget purposes, by the Coast Guard, the Auxiliary keeps them separate for reporting statistics. Also, your Miles and Costs for non-reimbursable expenses, reported under "99" entries, along with all of the other Mission Codes, are important as they are included when the Coast Guard prepares their budget for the Auxiliary.

Reporting/entering your missions/activities in AUXDATA II is a simple process after you have done it a few times. If you have not previously accessed AUXDATA II, the URL/link is <a href="https://uscg.force.com/auxcommunity/s/">https://uscg.force.com/auxcommunity/s/</a>. Next, click on "Forgot Your Password?" and enter your Username, e.g. your seven-digit Member ID followed by @uscg.aux (1234567@uscg.aux) and click on "Continue." You will receive a very long URL/link. Click that on that link and follow the instructions.

Excellent instructions for entering your information in AUXDATA II, are posted on the National website - www.cgaux.org. On the left side of the home page screen, click on AUXdata II. You will see "AUXDATA II ANNOUNCEMENTS" that includes the "Two Factor Authentication (2FA)" that is required to access AUXDATA II. Next, click on "Member How To." There you will see "AUXDATA II How To Guides and Instructions for Members" that includes information about 20 different AUXDATA II subjects, plus information about using AUXDATA II. If you are not familiar with AUXDATA II terminology and features, check out "How to Understand the Basics of AUXDATA II," it should alleviate any anxiety that you may have,

And always remember – "Communication – the thread that binds and keeps an organization from unraveling at the seams." AUXDATA II is an important tool for communicating information and it NEEDS YOU!

However, within days Flotilla 19-01 elected to join with 19-02 at Goldsboro and Flotilla 19-04 was invited to a similar event at Manor Township in Lancaster County. Soon the problem became one of balancing staffing to assure good coverage. The solution was for Gregg Bollinger, Ed Seda and Jeff Wilt from 19-04 to attend the Manor Township event and Rick Young would work with Dave Blechertas and Jeff Kuhn from 19-05 at Lower Windsor Township. Flotillas 19-01 and 19-02 had already agreed to work together.

Among the three locations, in addition to the Auxiliary, representation was variously from the local police, county sheriff, multiple fire companies, EMTs, River Rescue, Pennsylvania Fish and Boat Commission, Pennsylvania Game Commission, and K-9 Volunteer Rescue. All of the events were well very attended by both adults and children. Lots of boating safety literature was distributed, but coloring books for the children was a popular attraction. It was also a perfect opportunity to engage members of the community and articulate the Auxiliary's key mission in recreational boating safety by promoting our courtesy vessel examinations and public education as well as marine safety and environmental protection. At the end of the evening the various event organizers were duly pleased with the Auxiliary's presence and as a division we are enthusiastic to say that we have already been invited back for next year.

National Night Out, began in 1984 as an outgrowth of several small events in southeastern Pennsylvania, now involves nearly 40 million people in 16,000 communities nationwide. From its origin of just having folks sit on their front porch and having their light on, it has evolved into numerous widespread major community events where residents can mingle with personnel from fire, police, emergency services and others.

In short, all it took was that one invitation to have an entire division participate in a major public affairs event but to also lay the groundwork for a return engagement next year—the lesson is to never leave any stone unturned! To quote Division 19 VCDR Ed Seda, "This was a great event for getting the Auxiliary's presence better known in the community."

### The TOPSIDE Newsletter

### **Archive is Now Online**

Coast Guard Auxiliary District Fifth-Northern (D5NR) is proud to introduce their newsletter TOPSIDE's online archive for all Auxiliarists, Active Duty and the public at-large to enjoy on the D5NR website at <a href="https://5nr.org/topside-archives/">https://5nr.org/topside-archives/</a>. TOPSIDE is the official newsletter of Auxiliary District Fifth-Northern. Launched in March 1943, it is the oldest continuously published Auxiliary newsletter in the U.S. The TOPSIDE online bibliotheca contains the most complete collection of TOPSIDE from March 1943 to present.

The second half of the twentieth century bore witness to the revolutionary development of the Coast Guard's volunteer organization that shaped the Auxiliary as it is today. Containing over 92 issues and more than 1,400 articles, the TOPSIDE online archive offers readers amazing insight into the Auxiliary and the Coast Guard throughout this period. Online users can search through every digital issue of TOPSIDE back to March 1943.

The district's Historian, Steve Marthouse, assembled a dedicated multi-disciplined team of members to find a cost-effective means to insure the preservation of the collection of old TOPSIDE newsletters. Soliciting help from an educational institution, the team - Melvin Borofsky, COMO Joe Giannattasio, Tim Marks, Linda Skvarla, Rick Taylor and Mark Wirtz digitally scanned each issue and uploaded them onto a section in the district's website where they could be stored and accessed.

TOPSIDE's online archive reveals a wealth of treasure from the Auxiliary's history. Gems include a 1944 article chronicling the Auxiliary's response to the "Great Atlantic Hurricane" of September that year, the golden 50-year anniversary fall 1989 issue featuring the "History, 5th (Northern Region) Coast Guard Auxiliary," and policy pieces including the 2003 essay about the Auxiliary being the only volunteer organization to be included in the newly created Department of Homeland Security.

The TOPSIDE archive is an integrated part of the Auxiliary District Fifth-Northern website. All users can browse and download issues in the online archive via <a href="https://5nr.org/topside-archives/">https://5nr.org/topside-archives/</a>. Users can browse by year and issue.



### Uniform Changes Coming

### **Uniform Changes Summary:**

- 1. 12/31/21 = The <u>tucked</u> ODU will no longer be an authorized uniform item. The only authorized ODU will be the <u>untucked</u> ODU.
- 2. 01/01/22 = The <u>untucked</u> ODU is now the only authorized ODU for Auxiliarists.
- 3. 12/31/21 = The Alternate Working Uniform (AWU) is authorized to be purchased and worn by all Auxiliarists. (Access Link below for details and more information.) An AWU procured by an Auxiliarist will be authorized to be worn until no longer serviceable.
- 3.b. The Alternate Working Uniform (AWU) will provide more sizing availability, and will allow those members who opt not to follow some the grooming standards to remain active and valuable members of the Auxiliary.
- 4. 2024 = The new Coast Guard Work Uniform (CGU) will be made available to Auxiliarists during Fiscal Year 2024 when the <u>untucked</u> ODU will begin to be phased out, over two years.
- 4.b. The new Coast Guard Work Uniform (CGU) will not be available in sizes that are larger than the sizes worn by the Active Duty; this means that the CGU may not be available to some of our members. (The Alternate Working Uniform [AWU] will provide more sizing availability, and may be worn instead of the CGU so they may remain active.)

The Coast Guard Working Uniform (CGU) is essentially the latest iteration of the CG Operational Dress Uniform (ODU). To the left is a photo of the CGU.

### **ORDERS:**

Out of the members from each Division that we fund, both must have never gone to an in person DTRAIN before OR one member that has never been to a DTRAIN in person before and the other must be an active member within that Division.

This list of members must be given to this office by midnight, Sunday, December 12, 2021.

The 2070 form for the members that my office is funding must be received by midnight, Sunday, January 16, 2022. If the 2070 form is not received OR if it is received but not filled out correctly, the member will not receive funding from my office.



### The History of the Auxiliary Blazer Badge

The Auxiliary Blue Blazer outfit may be substituted for most Auxiliary uniforms, for social events, including conference banquets. The Blue Blazer may be single-breasted, dark blue flannel, tropical worsted, or similar blend; two-or three-button, with civilian or Auxiliary buttons, and with pockets. A component unique to the outfit is the Auxiliary Patch, also known as the Auxiliary blazer badge.

It is extremely difficult to attempt to trace an exact history of the blazer badge because there are a number of origins from which the modern blazer, and the blazer badges that adorn them, descend. The first incarnation of the blazer began life as a rowing jacket in the early 1800's, worn by members of the rowing club of St. John's College, Cambridge. The club jackets were termed blazers because of the bright red cloth which were said to have created a "blaze" of color when worn by the rowers. Another theory places the origins of the blazer to the Captain of HMS Blazer who, in 1837, dressed his crew in dark blue double-breasted jackets adorned with brass buttons, in an effort to impress the visiting Queen Victoria. The attire met with the royal approval, and this style of jacket soon spread to other ships. This, today, is known commonly as the navy blazer. The opportunity to provide the wearer individual expression and individuality comes in the form of the blazer badge. Traditionally worn to denote membership or affiliation to a particular group or organization, but not exclusively for this purpose, the blazer badge adorns the out-breast pocket, adding a certain level of character to the garment.



By 1966 the Auxiliary blazer badge design changed to the silver "shield and crossed anchors" circled insignia of silver wire bullion on a black background. This version of the blazer patch began incorporating clutch back pins, which allows the patch to be removed or reapplied to a different jacket.

An alternative design was offered around 1975 of the silver eagle and crossed anchors emblem with a centered blue and gold shield, embroidered in colored metallic threads on black backing.

### The History of the Auxiliary Blazer Badge

Noted to be issued in the early 1970's, the current official blazer patch is round and contains a wire bullion Auxiliary logo with stars around it on a black felt backing with clutch back pins. The latest representation is the same design, but made with silver metallic thread.

All Auxiliary blazer patches are officially designed and approved by the National Board and offered through the Auxiliary Center (AUXCEN).

Just like any other item of Auxiliary outfits, the Blue Blazer has come a long way since it was first introduced. To this day, both blazers and blazer badges play major roles within the Auxiliary and can usually be seen on special occasions, particularly business meetings, social events and banquets, among others. The Blue Blazer appears to be one of those items of Auxiliary clothing that will continue to remain popular for many years to come and so the badges that adorn them will continue to remain as popular.





#### **NACON 2021 is Postponed**

As we all know, the Delta variant of COVID-19 is sweeping across the United States. The State of Florida is the nation's number one hot-spot, centered in the crosshairs of this virulent and seemingly relentless virus. It is being reported that currently there are ZERO hospital beds available in Orlando, so if a member was to become ill, even from a non-COVID related issue, they might be unable to obtain appropriate care.

The overarching concern of your Coast Guard and Coast Guard Auxiliary leadership in these never-to-be-forgotten times continues to be the safety of the workforce. Whether active duty, reserve, Auxiliary, or civilian, nothing is more important to me, to the Commandant, and to the Secretary of Homeland Security than protecting the health and well-being of those who serve.

If we have learned anything from our intensive risk management training, it is that we must constantly weigh the risks we are undertaking against the gain that would come from executing the mission. We are trained to do that when we are assigned to duty, and we are urged to utilize that same calculus in our daily lives. I have done that, and in consultation with the Chief Director of the Office of Auxiliary and Boating Safety, the Commandant, and multiple Flag Officers of our Coast Guard, I have concluded that there is no rational alternative to postponing NACON.

Without question, the training we receive, the connections we make, the information that we share, the relationships that we strengthen, and the camaraderie and fellowship that we enjoy at NACON contribute immeasurably to our being ready, resourceful, relevant, and resilient. But there is also no question that the risk posed to our lives and well-being by this deadly virus is real and far

outweighs the potential gain from holding NACON in August as planned.

I am exploring the options available to us, such as holding NACON later this year if conditions permit, or perhaps combining NACON with NTRAIN. Nothing is off the table, but my first priority must be the safety of our members. Travelling to Florida and meeting in person is just not consistent with honoring that priority.

Obviously, this is a fluid situation with critical information changing minute to minute. Guidance will be forth coming shortly regarding orders, hotel reservations, and airline tickets. Your patience and understanding will be greatly appreciated. Very respectfully,

1. Today, as we celebrate the Coast Guard's 231st birthday, I reflect on our rich history and heritage, as well as the extraordinary level of service of our talented Coast Guard workforce delivered throughout the past year. Across the globe, our Service responded amidst the ongoing global pandemic, adapting to constantly changing conditions and always maintaining a taut watch. Every one of you—active duty, reserve, civilian, and auxiliary—delivered mission excellence and remained "Always Ready."

- 2. The Coast Guard performs complex missions in the most challenging maritime environments. Our multi-mission capabilities, broad authorities, organizational agility and flexibility, and incident response expertise position the Service for excellence and leadership in the maritime domain; this year is no exception. As Americans stepped-up to support their neighbors, and healthcare and service workers faced uncertain risks in their devoted care of others, our workforce faced each day with courage and skill. Coast Guard Day presents a terrific opportunity to pause for a moment and thank all those who have supported us through this dynamic 231st year.
- 3. What a year it has been. Amidst the COVID-19 pandemic, our operational units have been working incredibly hard, deployed globally to enhance maritime security, partnerships, and vital national interests. CGC POLAR STAR conducted a two-month winter patrol in the Arctic, the first such patrol in 38 years, while CGC HAMILTON completed a historic deployment to the Black Sea – our first major cutter patrol there since 2008. And CGC MIDGETT and CGC OLIVER BERRY recently participated in 3rd Fleet training exercises with the Carl Vinson Strike Group off Hawaii, while CGC MUNRO is currently enroute to support 7th Fleet and INDOPACOM operations. - 1. As announced in reference (a), the Coast Guard will start its final Go-Live system check and transition to the new DHS financial management and procurement system called the Financial Systems Modernization Solution (FSMS) from October 01, 2021 to November 15, 2021. The FSMS interfaces with many Coast Guard information systems including the Coast Guard's Auxiliary information system of record, AUXDATA II. During this time, referred to as the financial system blackout/cutover period, there will be significant impacts on all of these information systems including on the processing of Auxiliary patrol claims in AUXDATA II. Most notably, any Auxiliary patrol order claims submitted after October 01, 2021 will not be processed for reimbursement until after November 15, 2021.
- 2. In anticipation of the upcoming blackout/cutover period, any patrol orders currently in AUXDATA II need to be closed out prior to September 20, 2021.

This will allow several days to resolve any potential claim issues prior to the last allowable close out date of September 24, 2021. Any claims not processed prior to this date will not be processed by the Coast Guard Finance Center (FINCEN) until after the scheduled end of the blackout/cutover period, November 15, 2021.

- 3. Only Auxiliary patrols determined by the Order Issuing Authority (OIA) to be mission essential should be performed during the blackout/cutover period. Auxiliarists performing such patrols must understand that their claims for reimbursement of associated authorized expenses will not be settled until after the period's end, November 15, 2021.
- 4. If there are questions, please use your Chain of Leadership and Management (COLM) or Chain of Command as appropriate.

Mr. Brown enrolled in the Auxiliary in April 2014 and immediately became an active participant by holding various flotilla leadership positions including Vice Flotilla Commander and eventually Flotilla Commander. Along with serving as the District Commodore's Aide, in 2020 he was appointed as the National Branch Chief for Media/Video. He was instrumental to the development of the "Election of Unit Officers Through the Use of Electronic Means" Standard Operating Procedure, a comprehensive policy document issued by the Chief Director of Auxiliary that established ground-breaking procedures for the Auxiliary's virtual elections. His meticulous effort enabled rapid Auxiliary-wide familiarization with this new technology, facilitated successful conduct of over 1,000 time-sensitive Auxiliary elections, ensured Auxiliary leadership continuity despite the pandemic's restrictive impacts, and resoundingly proved the efficacy of virtual elections. Devoted to professional development and service, he also maintained currency as an Auxiliary instructor and vessel examiner, and logged over 745 hours of activity.

Until a link to record this course completion in AUXDATA II is established, Auxiliarists should still retain a copy of their course completion (electronic acceptable) to provide an Order Issuing Authority (OIA) if necessary.

Subj: AUXDATA II SKILLS AND AVAILABILITY SEARCH

- 1. AUXDATA II is now the primary database for searching for Auxiliarists' skills and availabilities, including willingness to travel and willingness to perform Coast Guard support missions. The former "Skills Bank" has been retired and is no longer accessible.
- 2. Auxiliarists' skills and occupational codes are based on Bureau of Labor Statistics (BLS) skills codes. They were updated from the 2010 codes in legacy AUXDATA to the more recent 2018 codes. In preparation for hurricane season, and because of the updated skills codes, ALAUX 012/21 asked all Auxiliarists to review and update their occupational skills, expertise, and availabilities in their AUXDATA II member records.
- 3. There are now several ways to search for skills and availability in AUXDATA II:

- a. By Member: This is useful when you want to determine the skills and availability of a known.
- b. By Skill: This is useful when you want to get a quick idea of how many Auxiliarists possess a specific skill. Although relatively easy, searching for skills in this manner does not allow for refining the search such as by district.
- c. By Members With Skills (A Report): The Members With Skills Report is the most useful way to search for skills and availability as well as to filter the results by any desired criteria such as district, willingness to travel, etc. The only limitation is the need to become familiar with how to create reports.

All District Directors of Auxiliary (DIRAUX), Operations Training Officers (OTO), and Auxiliarists must comply with the provisions in this Policy Letter.

# Subj: CYBERSECURITY BEST PRACTICES AWARENESS REMINDER

1. October is Cybersecurity Awareness Month. All Auxiliarists are strongly encouraged to remain vigilant against cybersecurity threats and to actively apply strong countermeasures in their personal and Auxiliary activities. In 2017, more than 300,000 individuals in over 150 countries fell victim to the WannaCry ransomware attack in a single weekend causing the loss of countless files and billions of dollars in damages. Threats like these are still prevalent and dangerous, and it is critical that we all

take the necessary steps to prevent an attack. The following ten practices are highly effective methods to achieve a strong cybersecurity posture:

- Use strong passwords and create separate passwords for each account.
- Use current and supported operating systems.
- Install all system security updates and patches.
- Keep antivirus software up to date.
- Regularly scan files for viruses.
- Install spyware protection software.
- Turn on firewall protection.
- Regularly back up and securely store files.
- Change default logon ID and passwords for operating systems and applications.
- Use caution when opening emails and do not view emails in preview pane mode.

It provided initial guidance for the resumption of inperson Auxiliary C-schools and limited attendance to individuals fully vaccinated against COVID-19. The policy letter was revised on 24 June 2021 to expand in-person Auxiliary C-school attendance to include unvaccinated individuals and define associated home unit Restriction of Movement (ROM) requirements.
